Venizelou Ave, GR-102 50 Athens, Greece; "user" means the natural person or legal entity requesting the material for use; "archival material" means a document, photograph, digital image/sound, or any other item that has been made available for reproduction; "reproduction" means any form of reproduction of archival material, including, but not limited to reproduction by mechanical, digital or electronic means (including reproduction for publication / broadcast over electronic networks/the internet). In the case of reproduction for TV use, a non-exclusive permission is granted for a single broadcast, unless otherwise stated in the Special Terms, whereas in the case of cinema use, a non-exclusive right of public screening is also granted.
2. The reproduction permission is granted upon the signing of this private agreement, together with any applicable special terms.
