Call for Papers
announcing the 11th Conference of the
South-East European Monetary History Network (SEEMHN)

hosted by the National Bank of Romania
in Bucharest, Romania
28 October 2016

Building on the success of the previous ten annual conferences of the South-East European Monetary History Network held in Sofia (BNB, University of National and World Economy) in 2006 and 2014, Vienna (OeNB) in 2007 and 2015, Athens (BoG) in 2008, Belgrade (NBS) in 2009, Istanbul (TCMB) in 2010, Bucharest (NBR) in 2011, Tirana (BA) in 2012 and Amiens (University of Picardie Jules Verne) in 2013, the National Bank of Romania takes great pleasure in hosting the 11th Annual Conference in October 2016. This reflects the National Bank of Romania's support to the SEEMH Network, whose main objective is to extend the knowledge of economic history of the Balkans as an integral part of the Pan-European experience with a specific focus on financial, monetary and banking history.

The **11th SEEMHN Conference** will take place on Friday, **28 October 2016**, in Bucharest. The topic of the conference will be

'Gaps and Economic Crisis in South-East Europe: Present and Past'

and is meant to put the researchers' spotlight onto economic and financial developments, the links between economic crises and the gaps that emerged in time between core economies and peripheral economies in Europe. Quantitative and qualitative research as well as national case studies and cross-country comparative work can be presented at this conference. This year, the SEEMHN Data Collection Task Force will continue its work with a new project concerning central bank balance sheet. In this context, any papers from both central bankers and academia on this subject are also welcome, to foster cooperation between them being one of the aims of this conference. Academician Daniel Dăianu, a former Finance Minister and currently a member of the NBR Board, has been invited to deliver the keynote speech.

All researchers from academic, central banking and commercial banking institutions are invited to submit paper-based proposals or to contribute to conference discussions. Researchers should submit their papers or extended proposal to Brîndușa Costache (brandusa.costache@bnro.ro) no later than **29 April 2016**. The authors of the accepted

papers will be notified no later than **31 May 2016**. The conference version of the paper and the presentation are expected by **30 September 2016**. The papers should meet the usual scientific standards and address the main topic of the conference in a broad interpretation. Selected papers will be published in the Conference Proceedings. Participation in the conference is not conditional upon presenting a paper. All participants are expected to cover their expenses.
